NH RSA 147-152 requires certain facilities licensed by the State to provide dementia care education to their staff. Initial training for direct care providers must be 6 hours and cover the five following areas: 1) Alzheimer's disease and dementia; 2) Person centered-care; 3) Assessment and care planning 4) Activities of daily living; 5) Dementia-related behaviors and communication. Initial training shall be complete only after the staff member has demonstrated related competency.
